**SUBJECT:** WIA Adult and Dislocated Worker Allocations for Fiscal Year 2013

**Purpose:**

Training and Employment Guidance Letter (TEGL) 19-11 provided state allotment levels for WIA Youth, Adult and Dislocated Worker for Program Year 2012. This notice announces WDA allocation levels for the FY 2013 (October) component of the Adult and Dislocated Worker programs, including Dislocated Worker mitigation through the release of the balance (\$1,165,455) of \$2 million pledged in state Rapid Response funds.
